







Learning to Improve Book Resource Operational Systems (LIBROS)-Cambodia Dissemination and Engagement Workshop Draft Concept Note

September 22, 2023, Fairfield by Mariott Phnom Penh

Background

LIBROS study is a part of the Supporting Holistic and Actionable Research in Education (SHARE), a five-year cooperative agreement with the University of Notre Dame (UND) to assist the United States Agency for International Development (USAID) in identifying policy and practice pathways to strengthening the primary school-level book supply chains in LMICs via case studies in Cambodia, Honduras, and Rwanda. LIBROS study uniquely encompassed three phases. The initial phase commenced with a diagnostic study aimed at laying out the general situation of the book supply chain and the evidence ecosystem in Cambodia. Phase 2 convened stakeholders across the book supply chain to participate in a two-day system thinking workshop to identify the improvement policy or intervention and contextualize, inform, and co-create the research design to be carried out in Phase 3.

For Cambodia, the selected improvement strategy or case studied by CDRI in Phase 3 is Track and Track (TnT) or, currently, the Core Textbook Supply Management System. Specifically, the study aimed to examine what impacts TnT has generated and to investigate the enabling and hindering factors to the development and uptake of TnT. This research endeavour is significant in expanding the evidence around enabling conditions or support mechanisms for improving the book supply chain. It will also be instrumental for donors, domestic governments, and practitioners in and beyond the three case countries selected in identifying effective policies, programs or solutions to strengthening the book supply chain system and understanding areas of further development.

As we reached the conclusion of this study, CDRI is pleased to present the research findings and share lessons learnt from the other two studied countries to our stakeholders in the hope that they will become relevant inputs for future policy development, discussion, and implementation. It is also our great pleasure to convene the book supply chain stakeholders to discuss and build potential networks and partnerships.

Objectives

This dissemination and engagement workshop will convene relevant stakeholders from government agencies, book developers (authors, editors, illustrators etc.), book publishers and distributors, development partners, and local and international civil society organizations (CSOs) working not only in the area of the book supply chain but also communication system and digital technology for the fruitful public discussion and cooperation.

The main objectives of the workshop are to:

Recap the activities and achievements from the three phases of the LIBROS study









- Disseminate the results of the LIBROS-Cambodia study, specifically on the case of Track and Trace (TnT);
- Share and discuss the findings and good lessons learnt from Honduras and Rwanda case studies in relation to policies or interventions that brought about improvements in the book supply chain;
- Provide a platform for policy discussion and cooperative engagement;
- Brainstorm innovative book supply chain models and formulate policy suggestions and recommendations.
